SUBJECT: Authority to Issue Warrants

Under section 6-5-9 NMSA 1978, the Secretary of the Department of Finance and Administration may authorize state agencies to issue warrants and exempt state agencies from the requirement of prior submission of proposed vouchers, purchase orders or contracts to the Financial Control Division as required under Section 6-5-3 NMSA 1978. As required under statue, DFA has established the conditions and standards that agencies must meet in order to be eligible to issue warrants or be exempted from submissions of proposed vouchers, purchase orders or contracts. Procedures related to the application and conditions of approval are contained in NMAC rule 2.20.6.

Authorization must be requested by completing and returning Attachment II, Request for Authority to Issue Warrants, to the DFA Cabinet Secretary. This submission will describe in detail the reasons why efficiency or economy will be better served by the State agency issuing warrants or waving the prior submission requirements. This memorandum serves as a reminder that requests for fiscal year 2023 (July 1, 2022 - June 30, 2023) are due December 31, 2021. Please note, that DFA can only accept requests bearing the signature of the cabinet secretary or agency head in office as of December 31. For your reference, Attachment I. contains a listing of approved requests for FY22.

A submission will not be deemed complete, unless it contains a detailed report describing how your agency complied with each of the eleven standards and conditions outlined in rule 2.20.6 during the past calendar year (January 1, 2021 – December 31, 2021, see enclosed rule template).

Section MIS12 of the Fiscal Year 2021 Closing Instructions and Attachment A - Year End Summary of Deadlines published by the Financial Control Division of the Department of Finance and Administration (DFA), provides additional process background and instructions for agencies seeking the authority to issue warrants or exceptions from the requirement of prior submission of financial documents.

The request form for fiscal year 2023 and report on compliance for calendar year 2021 for are due at DFA by December 31, 2021.
