The Indian Health Services and Acoma Pueblo has updated their annual SDS project and priorities for water and wastewater system improvements and new construction. All programs were informed and a report was presented to the general public at a tribal General Meeting.

Programs were informed of the ICIP process and requirements. All programs provided input and projects. The Tribal Administration completed the final review and approval.

#### Goals

The Pueblo of Acoma has selected goals and objectives for its transportation, water, wastewater, public buildings and infrastructure systems including public facilities and parks: These are; To provide safe and convenient public access within the Reservation. To provide public access to new Reservation development. To complement surrounding public transportation facilities as part of the area-wide public transportation system. To assist in the economic development of the Reservation.

#### **Factors/Trends Considered**

Infrastructure systems at Acoma are inadequate, undersized, and sub-standard and need improvements or installation. This includes water, wastewater, roads, bridges, public buildings, etc. In some cases, there are no existing infrastructure systems including natural gas service lines, digital communication lines, etc. Yet, the Acoma Pueblo community population continues to grow in number. For the past 30 years, Acoma Pueblo has seen a significant growth on creating jobs at tribal businesses. As the number of jobs are increased, housing has not increased and overcrowding conditions exist. Schools and community service programs face reduction in funds yet the need for services increases. Acoma Pueblo is rural, isolated and at-risk.

On December 24, 2008, Baahaali Chapter became the 10th chapter to achieve Local Governance Act (LGA) Certification by the Transportation and Community Development Committee, TCDC, of the 9Navajo Nation. Presently, Baahaali is funded largely by Navajo Nation. With LGA Certification, the chapter is now eligible for funds from the Federal and State Governments, the Bureau of Indian Affairs, the Indian Health Services and private foundations. The 2010 Census indicates a major decline in population from the 2000 Census of 1,622 to 918 community members. #### Process

The process at Cochiti Pueblo is to start with the previous ICIP input and look at priorities from the previous year and the completed projects, if any. The Chief Planner then takes the list of projects to the administrator and the administrative staff, including department heads and the maintenance supervisor, who is responsible for the sewer and water resources and building maintenance. The staff and the Administrator then take a new list with priorities to the Governors for review. The Governors schedule a time during Tribal Council to discuss projects and priorities. The Tribal Council is made up of about 40 permanent members and represents both clans of the tribe, all members of the community. The Tribal Council makes all decisions concerning infrastructure, buildings, and financial matters of the tribe and the community. Once a consensus is reached, the Tribal Council passes a resolution. The ICIP projects are listed for the community during community outreach days, usually held two to three times per year. The Chief Planner or Tribal Planner will post the projects and explain the process to community members. Community members only have informal input to the planning process.

#### Goals

The overall goal of Cochiti Pueblo is to provide a safe and healthy environment for the community. The tribe has existed at their current location for hundreds of years and wishes to remain with most of its members at the current location. To do this they believe that they must retain their culture and language and live and work together. Therefore, maintaining the infrastructure and environment are very important to their survival.

### Factors/Trends Considered

Over the last few years Cochiti Pueblo has been in a process to upgrade its deteriorating water and sewer systems and remodel or replace its buildings. They have been successful in this effort, but still have projects to make these improvements. The community is very supportive of these effects and appreciates not having the problems that plagued them for several decades. The other factor is the lack of economic development in the community over the last 30 years. The lack of financial resources has meant that the tribe has relied on government grants and assistance. Because of the reductions in this assistance, the tribe is embarking on projects to provide economic development to the community. These projects are aimed to produce funds to support capital projects and to provide for maintenance and operations of facilities and programs. Economic development has the added benefit of providing services and jobs to the community which is likely to keep tribal members on the reservation participating in the culture and language.

#### Process

The planning process is open to all Jemez Pueblo tribal members, Pueblo residents, and employees of the Pueblo. The resulting plan is a product of the Pueblo as a whole rather than a reflection of a few individuals or special interest groups. There is a 20-member Interdisciplinary Team (referred to as ID Team hereafter) comprised of representatives from the tribal administration and from each of the Tribe's departments. The ID Team meets to develop a current list of issues that need to be addressed in the comprehensive planning process that is based on community data as well as Department and Program needs. They also address long range planning issues and concerns. Relevant federal, state, and county planning documents have been reviewed to learn about growth and development projections and plans for the region. This process allows the Pueblo to remain up-to-date on local and regional initiatives and to ensure consistency. Community based planning has been an on-going process at the Pueblo of Jemez since the 1970's. The community has been involved at all levels through various outreach methods, such as focus groups, vision sessions, and community surveys, to name a few. To encourage tribal member participation, several approaches have been used by the Pueblo of Jemez in our current comprehensive planning process. The two primary means of soliciting tribal input were through Community Visioning sessions and an open house. Visioning sessions were held which included focus groups in 2010 and continued into 2011, 2012 and 2013. The most recent input was obtained through Tribal Council meetings in that they are the "voice" of the community. In addition, the Tribe publishes an Annual Report which lists the challenges and goals that are to be met. The overriding concerns of community members continues to be the following issues: housing; education; recreation and fitness; governmental organization; land and resources; mental health and social services; elder services; infrastructure including broadband access; economi

#### Goals

The Pueblo of Jemez developed a comprehensive plan which includes surveys of community members and studied the existing conditions and trends of growth and the probable future requirements of its territory and residents. The comprehensive plan includes the purpose of guiding and accomplishing a coordinated, adjusted and harmonious development of the Pueblo's territory which will, in accordance with present and probable future needs and resources best promote the health, safety, morals, order, convenience, culture, prosperity and general welfare of tribal members, residents, and workers at the Pueblo of Jemez. The Pueblo of Jemez Comprehensive Plan is updated and reviewed every 10 years. The Pueblo of Jemez Long-range Transportation Plan is updated every 5 years.

#### **Factors/Trends Considered**

The trend at Jemez Pueblo is increasing coordination and Pueblo-wide planning in addition to larger-scale community visioning and organizational accountability for meeting goals and objectives. The planning process provides for each of the Pueblo's departments and programs to work collaboratively to improve mutual understanding of each other's missions, goals, and professional perspectives. Working together to shape and develop the comprehensive plan, the departments can share information, maximize efficient use of funds, and cultivate greater communication and cooperation. Planning will improve the management of tribal lands and resources in a manner consistent with the community's goals defined in visioning and planning workshops. Decisions made about the development on Jemez Pueblo's lands will be done cooperatively and take into account all land and resource uses and needs. The broad scope and context of the plan will promote cohesion between tribal programs and administrative initiatives.

#### Process

The process for developing an Infrastructure Capital Improvement Plan for the Mescalero Apache Tribe built upon planning initiatives begun in 2003, first through development of a Source Water Protection Plan, then Phase I of the Tribal Integrated Resource Management Plan (IRMP), and the current interdepartmental effort to develop a Tribal Zoning Ordinance. The first phase of the IRMP consisted entirely of collecting community input through interdepartmental meetings, focus groups and larger public meetings. This provided much of the basis for the public input component to develop the ICIP. In addition, the Tribal Council has developed a Strategic Plan, identifying Tribal needs and priorities, and incorporating the need to develop sustainable Economic Development ventures to meet the needs of a rapidly growing Tribe. Towards this end, the Tribe is currently in the process of developing Comprehensive Economic Development Strategies, through funding received through the Economic Development Administration. Community participation is central to each stage of the Tribal planning process.

#### Goals

The goals of the Mescalero Apache Tribe in developing an Infrastructure Capital Improvement Plan are not that unlike other communities and municipalities desiring to provide clean, safe homes and neighborhoods where their children can be raised, state of the art educational opportunities, and meaningful employment to provide for our families. However, what does distinguish the planning goals of our Tribe, is the need to integrate the Apache cultural lifestyle, traditional practices and native language into all aspects of the process. The roots of Apache culture share common ground with "modern concepts" of community voice and input, as well as coordinated and collaborative efforts. This is how the Apache people survived in a sometimes harsh landscape - by working together.

#### **Factors/Trends Considered**

Other factors to consider in the planning process for the Mescalero Apache Tribe is the natural landscape in which we live. The Mescalero Apache Reservation is located within the Sacramento Mountains, where terrain, elevation, and weather extremes greatly impact project development and implementation. Although reservation lands encompass 460,000 acres, much of the landscape consists of steep slopes, shallow rocky soils and historic floodplains. This makes development of infrastructure more difficult and expensive, and limits some types of development. All of these considerations must be factored into the planning process.

Nageezi Chapter is funded by the Navajo Nation for the operation of the Chapter. Population the Nageezi Chapter is approximately 3000 Navajo people.

Nageezi Chapter lacks financial resources to fully finance capital projects within Nageezi community. Through Community Participation, Community Assessment, Utility Infrastructure Analysis, and Feasibility Studies for Economic Development; Nageezi Chapter's road system includes many miles of unpaved and unmaintained roads, Nageezi Chapter lacks utility infrastructures, Nageezi Chapter lacks commercial development that would otherwise provide basic good and services, create jobs and generate tax revenues, Nageezi Chapter lacks park and recreation areas, Nageezi Chapter sewer lagoon system is over 30 years old and will not be able to accommodate the growing population of Nageezi, and Nageezi Chapter Senior Citizen facility is over 25 years old and is no longer able to accommodate the increasing number of Navajo Senior Citizens utilizing the existing facility. Due to Nageezi Chapter being located in the checkerboard area in San Juan County, the region's checkerboard land ownership and jurisdiction hinders progress and community development projects, which increases the cost dramatically.

# **ICIP Entity Profile for Picuris Pueblo**

Entity Planning: Process, Nature/Effect/Options/Recommendations of Trends

## Process

The Pueblo of Picuris has managed to survive as a viable entity since time in memorial in spite of its geographical remoteness and its small population of 386 tribal members. Within the Tribal interior boundaries of Picuris, there is a patchwork of private land. This land includes the Spanish heritage villages of Rio Lucio, Penasco, Chamisal, Vadito and Rodarte. The Picuris Pueblo, and the mentioned communities share many of the same problems and opportunities. Employment opportunities for tribal members, as well as community members are scarce. Job opportunities are few and far between due to the remote location of the Pueblo lands. There is an urgent need for economic development opportunities for the Pueblo and its tribal and other community members. Information taken from the 2001 Pueblo of Picuris Labor Force Data indicates that unemployment is 35 percent of the available work force in the Pueblo. This translates into an abnormally high level of unemployment and or underemployment in a small geographic community such as Picuris Pueblo and surrounding areas. Tribal officials have also indicated that some of the reasons for the high level of unemployment include the lack of adequate infrastructure required for economic prosperity, such as water, sewer, communication, the lack of adequate resources such as buildings, equipment, technology, the lack of employable skills, the lack of high school diploma or GED certificate; the lack of child care, the lack of viable job opportunities in the Pueblo and lack of transportation, and substance abuse. The purpose of the Infrastructure Capital Improvement Plan is to adequately plan for future community development initiatives in the areas of water, wastewater, roads, community service facilities, housing, parks, equipment, and economic development initiatives, to name a few. The Pueblo of Picuris tribal government has requested the local community members to participate in this vital ICIP planning process, which is extremely important because it assists in building community consensus and gives direction to the Pueblo of Picuris future as a viable community. The Tribal Council met to discuss the ICIP program and to discuss the capital needs of the Pueblo. Using 2018 information and the current state of all the Pueblos capital assets the tribal council made decisions as to the priorities for the next year based on their knowledge of the assets as well as income and funding from other sources. The public is informed of priorities during our quarterly community meetings and are given an opportunity to voice their priorities. One of many items the community desires is to encourage and support the Pueblos Tiwa language program; this will be accomplished by ensuring the existing Cultural/Visitor Center is rehabilitated in order to have the resource to support the Pueblos language program.

#### Goals

Picuris Pueblos proposed Overall Economic Development Plan (OEDP) is in response to the Pueblos mission to promote, create, and support future sustainable long-term social, health, educational, technological, business, and economic development opportunities for the Pueblo and its Tribal members. Because it has become such a high priority for the Pueblo, the Tribal Council has developed and signed a resolution supporting and approving the development of a comprehensive Infrastructure Capital Improvement Plan, which will act as a blueprint for the creation and development of future prosperity for the Pueblo. The overall goal of the Pueblo for capital improvement is to seek funding to preserve the current infrastructure as much as possible to ensure the buildings function properly and are updated to meet Federal guidelines for Handicapped access. We also want to remediate some buildings that have fallen into disrepair due to flooding, mold and other problems. We also seek addition capital outlays to build economic development projects to provide income to the tribe. Timing: A lot of our projects would be completed in one fiscal cycle (Jan 1- Dec 31) or 1-2 years.

Costs of design: We RFP all our engineering and design. Site preparation: Environmental, archaeological and cultural clearances are always

done prior to work on any site. Soil analysis is also done to ensure the site can be built upon. Equipment: RFP on any equipment over 5K. Equipment bought that meets standards per design. Furnishing(s): RFP on furnishings. Furnishings kept at minimal functionality. Maintenance and operation: The tribe develops O&M plans for new buildings and/or projects.

## **Factors/Trends Considered**

The Pueblo has traditionally relied on farming, stock-raising, and hunting for their subsistence, but today these activities have been almost entirely abandoned. There has been a steady exodus from the reservation in recent years as tribal members seek outside wage work on a permanent and semi-permanent basis. According to a 2001 Labor Force Report, unemployment is 35% of the total labor force available within the Pueblo. The major trend has been the lack of adequate trained people. We attempt to train our people but due to the remote location of the Pueblo and more opportunities available elsewhere, we lose people and have high turnover in our positions at the Pueblo. This lack of continuity hurts the Pueblo. The Pueblo realizes this and with funding from NMFA a Master Plan has been developed and approved to assist the Pueblo to capture the vision of what the Pueblo can become so they have incentives to stay and work, know they are laying the foundation for a greater Pueblo. Through quarterly community meetings and daily communications with Pueblo members there is a strong desire to continue the Tiwa Language program because there is currently only a hand full of fluent Tiwa speakers many of which are elders; the language program is currently funded by the BIE and some tribal funds and have no facility to accommodate the program adequately. The Chapter is working toward achieving Local Governance Act Certification with the Navajo Nation which would allow the Chapter access to a limited and to seek funding from other sources than those listed above. The tax funds are limited to taxes paid from local business located within the Chapter Boundaries.way, including tap-ins into existing mains.

Another trend that concerns us is increasing regulation from all levels of government. At the Tribal level, that means additional costs in our projects for right-of-way permit and planning & zoning permits, variances, and reviews. The Highway Department now requires costly surveys and mapping of any work done in their rights-of-federal level we are closely watching the new EPA regulations.

The Chapter was certified by the Navajo Tribal Council on December 29 1982 as a new chapter. Then in March 2007, the Chapter become Local Governance Act (LGA) certified. The chapter is funded largely by Navajo Nation and Federal funds. (Bureau of Indian Affairs and Indian Health Service) We currently serve 636 chapter members based on the 2010 Census.

The Chapter has a Multi-Purpose Facility, which was constructed with funding from the Navajo Nation, State of New Mexico, AML and HUD. Other facilities include an older building and a warehouse. Water Projects in the chapter area are general funded by the Federal Government (Indian Health Service).

Population growth has been a trend that has always been a real challenge for us and we expect that to continue to increase. The growth we have already experienced combined with the additional facilities needed have resulted in seeking funding outside of the Navajo Nation.

## Process

The Tribal Council of the Pueblo of Santa Ana is the decision, policy making and governing body of the Pueblo of Santa Ana (Pueblo) and is empowered to oversee all financial obligations and use of all Pueblo lands, resources and assets. The Pueblo has adopted various laws, ordinances, and regulations in its secular government and business operations. Once a capital project is identified, approved and/or funded by the Tribal Council it authorizes the Governor and/or his designee to implement the project/program. The Pueblo remains in compliance with requirements of the Grant Agreements with the NM Indian Affairs Department and other State departments regarding Capital Outlay and Tribal Infrastructure Funding (TIF). The Pueblo works in coordination with professional, architectural and engineering firms to plan, design, develop and construct capital projects.

## Goals

The Pueblo of Santa Ana has pursued a strategy of developing tribal enterprises, realizing that economic independence is crucial to maintaining and safeguarding the traditional concepts and cultural values. The Pueblo has formulated an economic development and community policy for its tribal members, business enterprises and programs that pays careful attention and consideration to: 1) Improving the quality of life through tribal governmental services; and 2) Creating a diverse and sustainable economy; and 3) Pursuing projects in step with cultural and natural preservation and restoration; and 4) Maintaining and protecting its capital assets. The Pueblo has committed substantial amounts of its financial resources to implement economic and community policies, practices and projects. In times of scarce resources the Pueblo through the Tribal Council has implemented a systematic capital improvement plan for its capital, infrastructure and land use requirements.

## **Factors/Trends Considered**

The Pueblo of Santa Ana currently consists of approximately 1,000 tribal members with a land base of approximately 139,000 acres of trust and fee lands. The Pueblo is located 20 miles north of Albuquerque, New Mexico and is easily accessible by Interstate 25, US Highway 550 and State Roads 528 and 313. The Pueblo, through Tribal Council authorization, uses its financial resources to provide for essential governmental operations and services. Because of the small population base of the Pueblo and the continued federal funding cuts the Pueblo receives inadequate federal government funding to support all the needs of the Pueblo such as: water resources development, housing, education, health & wellness facilities, law enforcement and infrastructure, etc. To supplement Pueblo resources the Pueblo requests and receives capital outlay and TIF funding from the State of New Mexico. Under the New Mexico Indian Gaming Compact the Pueblo submits on a quarterly basis to the State of New Mexico a percentage of its revenues from its Class III gaming operations. The amount of revenues remitted to the State would be more than sufficient to provide for the needs of the tribal members were the revenues to remain at the Pueblo. With the substantial amount of revenues sent to the State the Pueblo will hold the State responsible for its financial support to provide for essential governmental services and infrastructure needs

Hence, health and wellness becomes the responsibility of the educational entities and becomes a part of the overall school mission.

Santa Fe Indian School was transferred in trust to the 19 Pueblo Governors in 2000. The land was transferred to the school with no resources to manage the land in trust. The responsibility to manage the land falls to the school. By developing the trust property through economic development, SFIS, seeks to generate additional resources to support management of the land and to support the school programs.

The Santo Domingo Tribal Programs Administration solicited the tribal leadership and program directors for project ideas. Then meetings were held with Tribal Government Leadership, including Tribal Council, to inform and vet tribal projects with them. Additional meetings with facilities staff, utilities department director and staff, including the tribal housing board and staff to finalize the list. - 2. Plan, design construct new water wells

The Teec Nos Pos Chapter is a recognized Navajo Nation Chapter Government under the Navajo Tribal Council and is funded largely by Navajo Nation and Federal funds from Bureau of Indian Affairs and Indian Health Services. We currently serve approximately 1500 people.

The community has not constructively developed since 1970 and only relies on what was established in years past. These buildings have been constructed with Navajo Nation funding. Water Projects in the chapter area are general funded by the Federal Government (Indian Health Service). Powerline Extensions are funded by general funds of the Navajo Nation.

Population growth has been a trend that has always been a real challenge for us, and we expect that to continue to increase. The growth we have already experienced combined with the barely adequate Chapter facilities have resulted in the chapter need to seek funding outside of the Navajo Nation, the Bureau of Indian Affairs (BIA) and the Indian Health Service (IHS). Tse al naozti i Chapter was certified by the Navajo Tribal Council in 1955 and is primarily funded by the Navajo Nation and Federal funds, Bureau of Indian Affairs and Indian Health Services. We currently serve approximately 4000 people.

Ever increasing population & community expansion has always been a challenging task for us. The growth we have already experienced combined with the barely adequate Chapter facilities have resulted in seeking additional funding outside of the Navajo Nation, the Bureau of Indian Affairs and the Indian Health Service.

Water Projects in the chapter area are general funded by the Federal Government-Indian Health Service.

Population growth has been a trend that has always been a real challenge for us, and we expect that to continue to increase. The growth we have already experienced combined with the barely adequate Chapter facilities have resulted needing to seek funding outside of the Navajo Nation, the Bureau of Indian Affairs and the Indian Health Service. The Chapter is working toward achieving Local Governance Act Certification with the Navajo Nation which would allow the Chapter access to a limited and to seek funding from other sources than those listed above. The tax funds are limited to taxes paid from local business located within the Chapter Boundaries.

Another trend that concerns us is increasing regulation from all levels of government. At the Tribal level, that means additional costs in our projects for right-of-way permit and planning and zoning permits, variances, and reviews. The Highway Department now requires costly surveys and mapping of any work done in their rights-of-way, including tap-ins into existing mains. At the state and especially federal level we are closely watching the new EPA regulations.

There is also a mast part of the community within the Navajo Nation land and also extends to checkerboard area which consists of a mixture of Indian allotted land, New Mexico State Lands, Bureau of Land Management Lands and Navajo Nation tribal trust lands.

White Rock Chapter/community is served by two separate Utility companies. Jemez Mountain Electric, Coop. serves homes within the checkerboard area while the Navajo Tribal Utility Authority (NTUA) has jurisdiction to serve homes on the Navajo Nation reservation land. The White Rock Chapter was certified by the Navajo Tribal Council on February 14, 1956, and is funded largely by Navajo Nation. Navajo Nation also funnels small funds through PL638 by funding service providers that work at the chapter level.

The community services and communication are based on White Rock Chapter Local Government Administration. Regular telephone lines are not available for homes but limited cell phone coverage is available. A majority of community members rely on services provided by the Chapter Local Government such as employment, home repair, livestock issues, etc. Monthly planning and regular meetings are held to involve community members to make decisions and approve projects.

All projects are administered by Pueblo of Zia Tribal Administration. Tribal Departments (i.e. DOT, Utilities, Economic Development, Environmental Resources, Education, Finance, etc.) assess & recommend project priorities in specific areas. The Tribal Administration determines overall planning and prioritization based upon community need and in accordance with Pueblo of Zia Comprehensive Plan process as approved by the Pueblo of Zia Tribal Council.

## Goals

Childhood Development Center, Tribal Wellness Center, Wastewater Lagoon Expansion, Community Playground, and Zia Lake Improvements; Pueblo of Zia community infrastructure project to support local education and wellness for the Pueblo of Zia and surrounding Region; Support facilities for tribal youth, elders, health & education; sustainable agriculture; and renewable energy development.

## **Factors/Trends Considered**

The Pueblo of Zia is seeing significant positive impacts, including public health benefits, of recent water system upgrades and improvements implemented at the community. As well, POZ continues to focus on health and wellness activities, education and required community infrastructure upgrades which will provide increased economic development and job creation for the Zia Pueblo community, as well as local and Regional communities along the US Hwy. 550.

Sustainable, culturally-appropriate education and wellness projects to strengthen Zia's self-reliance through internal improvements and social opportunities, education, agriculture, traditional arts and cultural tourism remains the main driver for these projects. With total POZ median income & average household income at -44 percent and -32 percent -respectively- below 2010 U.S. Census levels, ZEZ is in critical need of strengthening early childhood development, community health, and social activities in the immediate and long-term future.

# **ICIP Entity Profile for Zuni Pueblo**

Entity Planning: Process, Nature/Effect/Options/Recommendations of Trends

#### Process

The Pueblo of Zuni sets priorities based on critical unmet needs of the community that have been identified by tribal programs. Unmet needs are prioritized based on the Pueblo's capital improvement plan. The development of the plan involved various tribal programs, departments, and tribal officials. The Pueblo disseminates information of proposed projects through community meetings with notices posted at local businesses to solicit citizen input and priority-setting. The Pueblo also shares this information at various community outreach events.

## Goals

The local capital improvements goals of the Pueblo of Zuni are as follows:

1. Identify and obtain funding sources from local, private, county, state, federal and legislative bodies to support project development. 2. Prepare necessary Environmental, Archaeological, Preliminary Engineering Reports (PER), and secure architectural and engineering services to plan, design and construct critical infrastructure conducive to support viable projects and businesses on the Zuni Indian Reservation.

3. Plan, design, and construct needed facilities in compliance with local, state, and national codes and agency requirements.

## **Factors/Trends Considered**

The Pueblo of Zuni located in rural west-central New Mexico is the largest and considered the most traditional of the 19 Pueblos. Total Zuni population is 13,056 as identified in the latest demographic survey conducted by the Zuni Census Office. The annual growth rate is approximately 2.5%. Zuni lands encompasses approximately 463,278 acres of rangelands, croplands and mixed conifer forest on the main reservation.
